- 1 The Socialist Federal Republic of Yugoslavia had deposited an instrument of acceptance of the Agreement on 14 October 1963. For each State having notified its succession in respect thereof, the Agreement entered into force on the day when that State became a Member of the Agency.
- 2 The Czechoslovak Socialist Republic had deposited an instrument of acceptance of the Agreement on 7 February 1968. For each State having notified its succession in respect thereof, the Agreement entered into force on the day when that State became a Member of the Agency.
- 3 The Agreement was accepted by the Federal Republic of Germany. The German Democratic Republic also deposited an instrument of acceptance of the Agreement on 30 October 1974, with a reservation concerning Sections 26 and 34. On 9 October 1990, the Federal Republic of Germany notified the Depositary inter alia that, following the "accession" of the German Democratic Republic to the Federal Republic of Germany with effect from 3 October 1990, the international treaties and agreements to which the Federal Republic of Germany was a contracting party would also apply to the territory of the former German Democratic Republic.
- 4 The Socialist Federal Republic of Yugoslavia had deposited an instrument of acceptance of the Agreement on 14 October 1963. The Federal Republic of Yugoslavia (Serbia and Montenegro) had notified the Depositary of its succession in respect of the Convention with effect from 27 April 1992. Following its notification of succession in respect thereof, the Agreement entered into force for Montenegro on the day when it became a Member of the Agency.
- 5 The instrument specified that acceptance was "for the Kingdom in Europe, Surinam and the Netherlands Antilles". In view of successive constitutional modifications, on 6 June 2011, the Netherlands provided the Depositary with a status report whereby the Agreement applies to: The Netherlands (European part) as of 29 August 1963, the Caribbean part of the Netherlands (the Islands of Bonaire, Sint Eustatius and Saba) as of 10 October 2010, Aruba as of 1 January 1986, Curação as of 10 October 2010 and Sint Maarten as of 10 October 2010.
- 6 The Agreement was accepted by the Union of Soviet Socialist Republics (USSR). On 26 December 1991, the Russian Federation notified the Depositary that the participation of the USSR "in all conventions, agreements and international legal instruments which were concluded within the Agency's framework or under its aegis is continued by the Russian Federation".
- 7 The Socialist Federal Republic of Yugoslavia had deposited an instrument of acceptance of the Agreement on 14 October 1963. On 28 April 1992 the Federal Republic of Yugoslavia (Serbia and Montenegro) notified the Depositary that it intended to "continue to fulfil all the rights conferred and obligations assumed by the SFRY in international relations", including "participation in international treaties ratified or acceded to by Yugoslavia." Subsequently, on 5 February 2002 the Federal Republic of Yugoslavia deposited a notification of succession to the Convention, and this notification became effective on the day when the Federal Republic of Yugoslavia (Serbia and Montenegro) became a Member opf the Agency. On 2 July 2006 the Republic of Serbia notified the Depositary that it intended "to continue to exercise its rights and honour its commitments deriving from international treaties concluded by Serbia and Montenegro."
- 8 The instrument of acceptance spedified that the Government of the United Kingdom would not apply the Agreement "in any of the territories for whose international relations they are responsible other than the Channel Islands and the Isle of Man". On 14 June 1986, the United Kingdom notified the Depositary that it wished to withdraw this territorial restriction.
